Further Government investment into Social Enterprise

Two initiatives to support social enterprises, the Social Enterprise Development and Investment Fund (SEDIF) and the Professional Partnership Project, were announced by Senator Ursula Stephens, Parliamentary Secretary for Social Inclusion and the Voluntary Sector, in Sydney on Tuesday. The Government's \$20 million investment in the SEDIF will be used to leverage funding from other sources. Social Enterprises growing strongly in the UK – despite the GFC

Social Enterprise Coalition, together with Royal Bank of Scotland, have compiled data from information provided by 350 social businesses across the UK. It includes the full list of 100 fastest growing social enterprises and the organisations leading the field in reporting their impact. The report reveals incredible growth in the sector revealing social enterprises were outperforming regular small businesses with 56 percent managing to improve turnover during the recession.
